2024 Parade Guidelines, Rules & Regulations

Parade Date: Monday, August 5, 2024

Parade Fee: \$5.00

- Participants must be at the marshalling area (Gladstone – below Comox Elementary School) **by 9:30 AM, Monday, August 5** for judging.
- Parade marshals will direct you to your space. Please do not drive non-parade vehicles down this street. **The parade will begin at 10:30 a.m. sharp!**
- Please do not throw confections to parade watchers. Instead, **HAND OUT** any giveaways so as not to cause injuries to spectators. **PLEASE DO NOT HAND OUT PEANUTS OR TREATS CONTAINING NUTS.**
- All float riders should be well secured so that falling off the float is not possible.
- Do not let the entry in front of you get too far ahead of you – the greatest complaint about past years' parade was the large spaces between some of the entries.
- All motor vehicles in the parade must have a valid B.C. license and registration.
- By submitting your application you agree to the parade rules below.
